Candidates must be from companies that are members of IFA. The individual may be living or deceased.

2009 BONNY LEVINE AWARD

Award Qualifications: Nominees for IFA's Bonny LeVine Award must be successful women franchise entrepreneurs or executives who have best served as mentors and role models for other women.

2009 ENTREPRENEUR OF THE YEAR AWARD

Award Qualifications: Nominees for IFA's Entrepreneur of the Year Award must be highly-successful franchise entrepreneurs with unique innovations and creative skills in the midst of building their companies.

2009 RONALD E. HARRISON AWARD

Award Qualifications: To recognize organizations and/or individuals who have made significant contributions to minorities in franchising either within their franchise organizations or within the franchise community.
